Reports:

Treasurer's Report: Todd Torres reported \$47,325 in checking account as of December 31, 2018. There is \$7,000 in the CD. Expenses for 2018 were approximately \$9,338 with the largest expense being for the Convention. There was a \$1,600 donation was made to the NC Swimmiong Hall of Fame. Todd reported that the relay expense varies year to year depending upon where Nationals are held. The newsletter honorarium of \$500 will continue in the future. The National Office has released an excel spreadsheet for LMSC treasurers to track expenses, and Todd commented that it is quite useful.

Registrar's Report: George Simon reported that as of April 6, 2019, there were 1,271 USMS members. NC LMSC received \$836 in donations through registrations vs. \$1,450 in 2018. The number of printed card has decreased immensely due to online registration. George made a motion to have his Registrar ID remain on the USMS database. 2nd: Todd Torres Motion carries.

Continuing Business:

IM Madness - Joanne Wainwright reported that the postal event had 37 registered swimmers with 48 splashes and 18 t-shirts ordered. Total projected income generated from the event is \$876 and expenses \$370 (including a t-shirt for the person who finalized the design) resulting in a projected net profit of \$506. T-shirts are to be printed soon and will be mailed out by Celia Wolff.
